



## **Waiver of Liability and Hold Harmless Agreement**

The courts on which the Clayton Bocce League play are on private property. I am aware that the Clayton Bocce League has published rules of play, which include a Code of Conduct. I am also aware that the novel coronavirus, COVID-19 has been declared a worldwide pandemic by the World Health Organization, and has been, and will continue to be, the subject of ongoing published orders issued by the federal government, State of California, Contra Costa County Department of Health, and perhaps other governmental agencies.

**The CBCA has put in place preventative measures, as recommended by government agencies, to help reduce the spread of COVID-19. These measures include, but are not limited to, wearing an approved style of mask (covering nose and mouth) whenever present at the courts, frequent hand washing/hand sanitizer, social distancing and other sanitation measures that may be published and updated from time to time. However, neither CBCA, nor any other party to this agreement can guarantee that your risk of contracting COVID-19 will not increase, or that you will not test positive for COVID-19, by virtue of using these courts, even if you follow all guidelines issued by governmental agencies or the parties covered by this release.**

I hereby acknowledge that there are dangers and risks inherent in the game of bocce played on these courts, including the risks posed by the COVID-19 pandemic. Accordingly, by signing this Waiver of Liability and Hold Harmless Agreement (hereafter, Agreement) the undersigned, either for myself or as guardian of a minor, hereby fully and voluntarily assume such risks and waive and release the Clayton Business & Community Association, Inc. (hereafter, CBCA), individual members of the CBCA bocce committee, Skipolini's Inc., and the Lester L. Ipsen, Jr. and Beverly A. Ipsen Declaration of Trust, dated March 31, 1986 (hereafter, Ipsen) from any and all claims for personal injury, property damage, or death that may result from my participation in the playing of bocce through the Clayton Bocce League. In particular, I hereby agree to abide by all rules, instructions, policies and procedures imposed by the Clayton Bocce League relating to the use of the facilities or property. By signing this Agreement, I fully assume the dangers and risks, and agree to indemnify and hold harmless CBCA, Ipsen, and their respective employees, agents, and officers, from and against any and all liability incurred as a result of or in any manner related to my participation in the activities set forth herein. I hereby certify that I am of legal age and competent to execute this Agreement, that in doing so of my own free will and accord, voluntarily and without duress, and that I do so intending to bind myself, my executor, my heirs, and administrators or assigns to the fullest extent. Note: If you are under the age of eighteen (18) please have a parent or guardian sign the form. Thank you.
